

Practice Problems

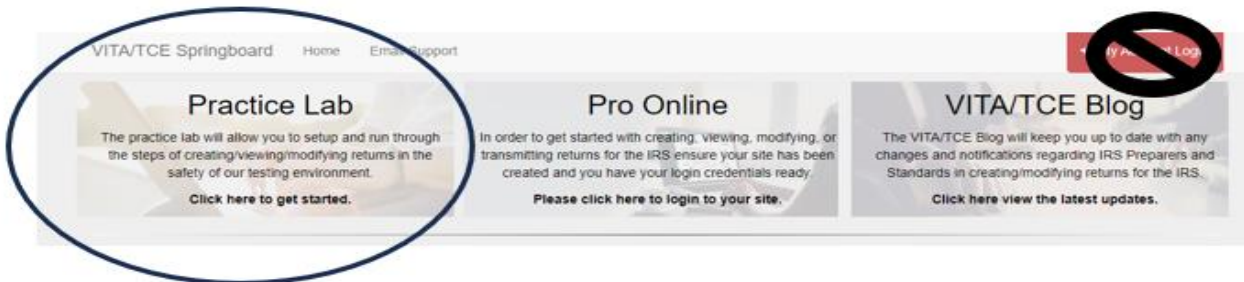

- At the tax site you will need to go through the E-File section of the return to complete it. Tab K is a helpful resource for this section. For the test and for training you do not need to complete this section if you do not want to.
- Select **Start a New Return** to begin the data entry for the tax return.
- Select **Client Search** if you want to look for a return already complete or one in progress.

We have created scenarios for you to work on along with a spreadsheet with results (AGI, Amount of Tax and Result) for you to check.

12/4/2023 note: The state return information has not been loaded into the system yet. For your tax test there are no questions related to the state return. When it's loaded you will be prompted to select a locality for the tax customer. For the practice problems (or test) select any VA locality and answer "yes" that a return was filed last year. You do not have to answer the questions below on the sales/use tax.
