2024 United for ALICE Report

The rising cost of living and the housing crisis are top of mind issues for many families in our region. Last month, United for ALICE released their 2024 update which unpacks important data on the most pressing obstacles to financial stability, such as the cost of housing, childcare, health care, groceries and more. United for ALICE is a nationwide advocacy movement which originated out of a desire to better understand the struggles facing everyday families. Founded by United Way of Northern New Jersey, the United for ALICE initiative has developed into a collaboration between several United Ways, government agencies, corporations and other nonprofits and foundations across the country.



ALICE is an acronym used to represent the often underrepresented populations who are not living in poverty, but are Asset Limited, Income Constrained, Employed. 38% of households in Virginia are

considered ALICE and 11 out of the 16 localities in our region have a higher percentage of ALICE families than the state average. These issues impact everyone in our society and take a tangible toll on our economy. At United Way, we are committed to raising awareness of the most pressing issues in our region, rallying a united effort to find solutions, and advocating for systems-level change so that all in our region can thrive. As a United for ALICE partner, we're leveraging this quality, unbiased data to inspire meaningful action and stimulate progress that will improve the financial stability of ALICE families, ultimately benefiting our entire community.








New Early Learning Trail in Chesterfield

Charitable Deduction Being Considered

Congress is considering reinstating the universal charitable deduction (UCD), which expired in 2021. The universal charitable deduction will make it easier for everyone, no matter their income, to support the work community-based organizations do daily throughout the country. The bipartisan Charitable Act (H.R. 3435/S. 566), provides a charitable tax deduction to taxpayers who claim the standard deduction. The current charitable deduction is only available to those who itemize, 12% of taxpayers. The Charitable Act has the potential to expand charitable giving and provide important resources for the organizations many Americans depend on to meet critical community needs.
